C. Board Policy 2000 – Curriculum Series (Action Item, First Reading) – Elizabeth Davis

Elizabeth Davis presented the revised 2000 Series Curriculum Policies.

A motion was made to approve the first reading of the proposed Board Policy 2000 Curriculum series, as presented.

The motion was amended to delete the current 2000 series policies and approve the first reading of the proposed Board Policy 2000 Curriculum series and Board Policy 10000 General Policy series, as presented.

Board discussion included an emphasis on the need to organize and streamline policies. Deliberation ensued over a portion of the policy terminology so as to clarify that placement decisions are ultimately the responsibility of the district. The transparency of administrative regulations was discussed, and the Board identified faith in our current administrative team. It was recommended that the procedure for adopting administrative regulations be discussed at a future work session. A process and regulation map will be reviewed at the next Superintendent Policy and Curriculum Committee meeting. Bob Lusk, of Lusk & Albertson, was present to provide input.

Lisa Kowalski, parent, recommended the need to clarify the Parental Involvement Policy (2000.02) to include an intention to work with various parent organizations.

Joshua Raymond, parent, recommended the public have the opportunity to review administrative guidelines and provide input before they are adopted.
