A. Superintendent's Committee Reports (Informational Item) Dana Taylor

Assistant Superintendent for Business Affairs Dana Taylor reported on her Superintendent Business and Operations Committee Meetings held on October 17 and November 14. Topics discussed at the October meeting included a proposal for an additional cell phone tower, and the organizational structure of the Operations Department. Topics discussed at the November meeting were the audit management letter, and the June 30, 2016 fiscal year-end results.

A. 2015-2016 District Audit (Action Item) Dana Taylor

Kim Lindsay, Principal Auditor from Lewis & Knopf CPA's, PC reviewed the unmodified audit opinion.

Dana Taylor presented an overview of the 2015-2016 Financial Statement including information on fall state aid membership, foundation allowance, general fund, capital projects fund, and food service fund. Also reviewed was the district retirement rate, MPSERS membership, and GASB 68 Reporting.

Board discussion included clarification of the decline in MPSERS membership, the unfunded MPSERS liability, and the forecast projections.

D. Bond Construction Project Bid Awards (Action Item) Dana Taylor

A motion was made to approve the Bond Construction Project Bid Awards, as presented.

A recommendation was made to award the contracts and approval of future project costs for Adams High School and Stoney Creek High School – Synthetic Turf Replacement to Astro Turf in the amount of \$1,023,076.00, plus other project costs in the amount of \$70.490.00 for a total of future project costs for Adams High School and Stoney Creek High School, in the amount of \$1,093,566.00.

Board discussion included clarification of the expected life of the astro turf field, and a timeline of field installation.

Doug Hill, REA President, addressed the Board regarding the "locked-in" rate, and clarification of the size discrepancies at the fields.

A recommendation was made to award the contract and approval of current project costs for Rochester High School – Addition and Renovations of Metal Roofing and Siding to MW Morss Roofing in the amount of \$105,525.00 and Hard Tile and Base to Southeastern Tile LLC in the amount of \$89,540.00 for the contract sum of \$195,065.00, plus other project costs in the amount of \$13,440.00 and including previously awarded contracts in the amount of \$17,020,322.00, for a total current project costs in the amount of \$17,228.827.00.
