Questions/Comments: I'm sure when you ran for and were elected to the position of Board of Education you had no idea that you would be making such difficult decisions during a pandemic. This has to be exhausting, overwhelming, time consuming, and stressful. Your dedication and efforts are appreciated. I did have some concerns about the new proposal that was adopted. I was completely shocked that it was passed with no plans for children who need to quarantine, be it if they are diagnosed, exposed, concerned for a family member (such as a family member needing to be healthy prior to surgery) or who is not comfortable returning to school. There needs to be a way for them to not fall behind. I'm especially thinking about students like my daughter who are in high school taking rigorous courses, where missing classes for 14 days at a time, perhaps multiple times during the school year seems like an undue hardship. I know that there is a committee working on this, but this plan should have been in place before reopening our schools. Many of the other school districts in our area were able to successfully implement a plan allowing students to remain getting live instruction while staying remote. How long until a plan is in place to allow students to learn from home? On March 13th you made the tough decision to switch to remote learning. This was before the earliest entry for Oakland County 7 Day Average, but on March 18th (the first recorded piece of data for this metric) there were 16 cases. On August 5th, an email was sent out stating that we were going to start the school year remote, and that, "Our vision is to transition back to in-person learning as conditions allow." At that time, according to the Oakland County 7 Day Average, there were 100 cases. As of October 24th, the 7 day average is 134 cases. Does this really look like the time to send students, teachers, and administrators into the schools now? If 16 cases was too high, and 100 was too high, what makes 134 now seem safe? What is the logic behind opening now? I'm also concerned about the 7 day case average that is being used a metric in this plan. I understand that this data is from the Oakland County Health Department, but they are using date of onset rather than date reported for this metric. The way that this is calculated artificially reduces the number of cases in a week. My understanding of this (and please correct me if I'm wrong) is that it requires a positive test, but then counts the date as the onset of symptoms. So if a child feels ill on the 1st, gets tested on the 2nd, and doesn't get their test results until the 5th (and 3 day turn around is rather quick from what I've heard) the date included in the average is the 1st – therefore the metric is only including this data for 2 days! If the parent waits longer to test the child, or the test results take longer to process, there is chance that their diagnosis will not ever be counted in the 7 day

average. This is a huge issue, as it underinflated the number of cases, thus asking for determine a risk factor to be determined with misleading numbers. Can you please confirm that this is the metric you are using and if so, would you explain why you're using data that inaccurately portrays the number of case or let us know what you are doing to adopt a more accurate metric to determine our Risk Level? Questions/Comments: It was nice to hear at the meeting last night that RCS is looking into a more robust hybrid program, particularly for the asynchronous days. However, I was very disturbed by Dr. Shaner's claims that: 1) He never expected the number of quarantined kids/staff to be as high as it is; 2) Hybrid was supposed to only be a stepping stone to full-person instruction, and nobody every expected our county's case numbers to rise as quickly as they did. Scientists, epidemiologists, the CDC, the MDHHS, and the OCHD have been warning us for months about a fall/winter spike. Furthermore, parents have been asking since July how RCS planned to educate quarantined kids. Nobody should be surprised that this happened, and nobody should be shocked by the number of quarantined individuals. In preparation for this, a more robust hybrid schedule should have been developed this summer, and RCS should absolutely have had a solid backup plan for how to continue the education of quarantined kids BEFORE we began sending them back to school. Sometimes, hindsight is genuinely 20/20. But (with all due respect) when the writing has been on the wall for months, that just becomes an excuse. I don't necessarily need anybody to contact me about this, but I would like to make sure that this message makes it into the board packet for the next meeting. Thank you for your time.

Questions/Comments: I really hope the real figures and data are being looked at and you are actually taking the time to analyze the actual data and not simply reacting and following the other districts returning to all remote learning. Here are some facts that, if you take the time to read, will calm this unsubstantiated fear down: Updated Oakland County stats for November 2nd vs April 2020 data: Oakland county positive cases 7 day average peak in the spring was 23.8/100,000. Currently it's 25.4/100,000. Our positive test rate was 40% on April 29th and currently it's 7.8%. Our 7 day death average in April was 21.1 and now it's 0.9. And our 14 day daily death rate is going down and is 0.24. Yes, the death rate is less than 1 as of November 1st data, but our positive cases are higher than ever. Also, statewide hospitalizations for Covid-19 were 3,824.5 for a 7 day average in April. November 1st the 7 day average is 1,501. (Down 61%) Also, the largest group of positive test results come from our 19-29 year old age bracket (529 positive cases). Our 2nd largest group is from 30-39 year olds(421 cases). Kids aged 5-13 have 111 total positive cases and kids 14-18 have 190 total, since March in Oakland County. (Data is from the end of October) school age children account for 11.7% of all positive test results. According to Oakland county's website, our healthcare capacity is still "strong". Our "testing, tracing, containment infrastructure" is "strong". And our 14 day average daily death rate is going down(0.24) Cases are higher than ever, deaths in Oakland county are going down. Hospitals remain in good shape, our testing and containment infrastructure is "strong". So in summary, positive tests are only part of the equation when determining severity of a disease spread. Again, there were 60.8 million positive tests results for H1N1 in the 2009 pandemic. But we didn't panic because the hospitals weren't overwhelmed for weeks on end, even though pediatric deaths were 6.5 times higher than Covid-19 during the same time period (477-74 March-August). CASES are a guide and can tell a story. They make us watch all the other indicators. However, all other indicators are still in our favor. Following only positive cases is a false narrative. We need to compare positive cases, with hospitalizations, deaths, testing ability, and hospital headroom. I hope this helps shed some light so people understand cases will rise and fall, and we need to watch them, but pay attention to ALL indicators. This is having a serious mental effect on so many children across the board. It is a very serious thing to be playing with.

Questions/Comments: To the RCS Board of Education. I wanted to make sure my feelings are known regarding in person learning. In short - I want my child back in school in person full time. This is our first year in the public schools - and I am not impressed. I have one child who has been in person since August full time with zero issues. Therefore, I cannot fathom why our District which is supposedly leading edge is so embarrassingly behind. Oakland County stats for November 2nd vs April 2020 data: Oakland county positive cases 7 day average peak in the spring was 23.8/100,000. Currently it's 25.4/100,000. Our positive test rate was 40% on April 29th and currently it's 7.8%. Our 7 day death average in April was 21.1 and now it's 0.9. And our 14 day daily death rate is going down and is 0.24. Yes, the death rate is less than 1 as of November 1st data, but our positive cases are higher than ever. Also, statewide hospitalizations for Covid-19 were 3,824.5 for a 7 day average in April. November 1st the 7 day average is 1.501. (Down 61%) Also, the largest group of positive test results come from our 19-29 year old age bracket (529 positive cases). Our 2nd largest group is from 30-39 year old's (421 cases). Kids aged 5-13 have 111 total positive cases and kids 14-18 have 190 total, since March in Oakland County. (Data is from the end of October) school age children account for 11.7% of all positive test results. According to Oakland county's website, our healthcare capacity is still "strong". Our "testing, tracing, containment infrastructure" is "strong". And our 14 day average daily death rate is going down(0.24) Cases are higher than ever, deaths in Oakland county are going down. Hospitals remain in good shape, our testing and containment infrastructure is "strong". So in summary, positive tests are only part of the equation when determining severity of a disease spread. Again, there were 60.8 million positive tests results for H1N1 in the 2009 pandemic. But we didn't panic because the hospitals weren't overwhelmed for weeks on end, even though pediatric deaths were 6.5 times higher than Covid-19 during the same time period (477-74 March-August). CASES are a guide and can tell a story. They make us watch all the other indicators. However, all other indicators are still in our favor. Following only positive cases is a false narrative. We need to compare positive cases, with hospitalizations, deaths, testing ability, and hospital headroom. I hope this helps shed some light so people understand cases will rise and fall, this virus is not going away any time soon and we need to watch them, but pay attention to ALL indicators. The willingness to sacrifice our children's education and mental health is negligent and

Questions/Comments: I just received a phone call in response to my earlier email from Kristen Patrona. While I truly appreciate that she reached out to see how Delta Kelly can support my children, she did not or could not address or answer any of the questions that I have asked of you all. At this point my children are falling behind, educationally and emotionally. I am asking you, because you are making the decisions that are depriving our children of their right to an education. I would like to know what you are doing to support your young learners. Ms. Patrona explained that middle school and high school have access to counselors. While I think that is fantastic, this does not help my children. I have been able to seek out therapy on my own for my children, but probably too late. It took a few weeks to find the right therapists to support them and to get them an appointment. A process I should have started weeks earlier, but I remained hopeful you were doing everything within your power to get our children back in person, which would have solved much of the issues they are trying to overcome. I would like to know from all of you, our district leadership, what are you doing to support the emotional well being of students in our district. Do you understand the impact of the decision to remain hybrid is affecting a large part of your student population? How do you anticipate making up for lost instructional time? My 4th graders spend a good percentage of time frustrated and behind. For example, one of my girls does not spell very well, combined with a lack of proficiency in the keyboard, typing is very frustrating for her. She falls behind and panics. The teacher, as wonderful as she is, does not see that this is happening and continues on with her remote lesson. Meanwhile, my child is melting down and is too embarrassed to ask the teacher to slow down, because she is 9 and has suddenly become self conscious. I then need to spend the next 30 minutes trying to help her regain some ground that she has lost after spending 15 minutes trying to calm her down. The pressure is extremely intense for her. She used to be a confident, out going kid, but this situation has made her feel like she is a failure. She has lost interest in school and melts down multiple times a day. This is real and something you continue to avoid. You are loosing these kids and refuse to answer these tough questions. How are you supporting her? What will you do to help her reach her goals of becoming a marine biologist someday? Because as hard as Mrs, McCarty, her father, and I try to keep her positive and moving forward, she just isn't. She is moving backwards. She deserves to be in a classroom where her teacher can see her and tell if she needs support. Where she doesn't feel like a failure, because she isn't. She is bright and has so much to offer this world. This situation is crushing her spirit. The decisions you have made to protect some are killing others. She is not the only one. My other daughter suffers as well and has lost interest in school. She has anxiety over lack of instruction and the 8 hours of class work that is assigned on asynchronous days. Even though they are in 4th grade, these days are void of recess because there is so much work to do. They take a lunch and a few 10 minute breaks to give their eyes a break. The balance is tough. I spend hours instructing because there is no instruction and their frustration of not understanding what to do on their own. Hybrid is a failure and has only solved one portion of the problem. Remote is a failure and only solves one portion of the problem. These kids need in person instruction. They deserve better. I know what you have done to support some of our community. What are you doing to support my kids and other kids in the district that are experiencing the negative affects of not having full time in person instruction? Please stop passing this off to others who do not have the authority to make changes. Please stop avoiding the question and revert back to the unprecedented times. You have a responsibility to make sure my children are in a thriving educational environment. What are you doing to support these kids who NEED in person instruction? You have offered and made available a virtual campus for those that do not feel comfortable or safe sending their children to school. How will you remedy this for my children to excel like they should be?

I do not doubt your empathy or your intelligence, and I certainly do not envy your position. My situation is important and unique to me, but no more so than the next person. The reality is that regardless of the decisions you make going forward about instruction in RCS, someone will suffer because one solution does not always solve every problem. Therefore, what are you, our trusted decision-makers, to do? Looking to how Covid-19 is unfolding in our community and across the country, public health measures aimed at strict adherence to radical changes in behavior are not working. We see family gatherings and Halloween parties on social media. We see health decisions being used as a proxy for political affiliation. We see the shield of collective responsibility being punctured by the sword of personal liberty. The effect of this is chaos in our school system and in our homes, mistrust in our community and an ugly divisiveness I have not seen in my time in RCS. Unfortunately, I do not see this ending anytime soon. Therefore, how do we funnel down to the best outcome for the most people? I think we need to peel back the layers of what schools have become and look at its core function: the education of children. Your job is to get education to the majority of students during a public health crisis, given everything we know, and, humbly, everything we do not. My children are high school students and it is for them I advocate a return to remote learning. Inperson instruction is a revolving door of quarantined teachers and students with inadequate mechanisms for continued instruction. The hybrid, albeit a temporary measure, is woefully inadequate instruction time and overwhelming our teachers, the effects of which my senior is especially aware. The remote model with which we began, although imperfect, delivers content in a structured manner with very little interruption. I am sure remote learning is not ideal for every learner, but given how this virus is spreading in our community, I do not see how else to avoid the chaos of quarantine at the high school level while serving the majority of students. Moreover, health data suggests we are not moving toward a safer in-person environment, a condition upon which you premised this transition. I am sure you have all had many sleepless nights as parents and as public servants. I appreciate all of you, especially those Board Members who volunteered to continuing serving knowing what you know.

Questions/Comments: We are hearing rumors that RCS is considering shutting all in-person education and this is very alarming! My wife and I chose our house specifically for the school district. Our two daughter have gone through North Hill (currently at Hart) while my son is in his last two years. We have had nothing but great experiences until this pandemic. We know decisions were very difficult last Spring, but as this year has gone along we have learned great amounts about this disease. In-person learning is very essential to my children's success in the future. Learning at the end of last school season was non-existent. This year with the hybrid as been better but still lacking. With the facts below, if the district decides to close again to in-person learning my family will have to make hard decision regarding RCS.

I really hope the Board of

Education are looking at real figures and actually taking the time to analyze the actual data and not simply reacting and following the other districts returning to all remote learning. Here are some facts that, if you take the time to read, will calm this unsubstantiated fear down: Updated Oakland County stats for November 2nd vs April 2020 data: Oakland county positive cases 7 day average peak in the spring was 23.8/100,000. Currently it's 25.4/100,000. Our positive test rate was 40% on April 29th and currently it's 7.8%. Our 7 day death average in April was 21.1 and now it's 0.9. And our 14 day daily death rate is going down and is 0.24. Yes, the death rate is less than 1 as of November 1st data, but our positive cases are higher than ever. Also, statewide hospitalizations for Covid-19 were 3,824.5 for a 7 day average in April. November 1st the 7 day average is 1,501. (Down 61%) Also, the largest group of positive test results come from our 19-29 year old age bracket (529 positive cases). Our 2nd largest group is from 30-39 year olds(421 cases). Kids aged 5-13 have 111 total positive cases and kids 14-18 have 190 total, since March in Oakland County. (Data is from the end of October) school age children account for 11.7% of all positive test results. According to Oakland county's website, our healthcare capacity is still "strong". Our "testing, tracing, containment infrastructure" is "strong". And our 14 day average daily death rate is going down(0.24) Cases are higher than ever, deaths in Oakland county are going down. Hospitals remain in good shape, our testing and containment infrastructure is "strong". So in summary, positive tests are only part of the equation when determining severity of a disease spread. Again, there were 60.8 million positive tests results for H1N1 in the 2009

pandemic. But we didn't panic because the hospitals weren't overwhelmed for weeks on end, even though pediatric deaths were 6.5 times higher than Covid-19 during the same time period

(477-74 March-August). CASES are a guide and can tell a story. They make us watch all the other indicators. However, all other indicators are still in our favor. Following only positive cases is a false narrative. We need to compare positive cases, with hospitalizations, deaths, testing ability, and hospital headroom. I hope this helps shed some light so people understand cases will rise and fall, and we need to watch them, but pay attention to ALL indicators. PLEASE KEEP OUR KIDS IN SCHOOL!

Subject: School District Budget Amendment for the 2020-2021 Fiscal Year

The following pages contain the Resolutions for an amendment to the general fund budget for the 2020-2021 school year.

The General Fund budget revenue increases \$15,635,671 related to adjustments due to the COVID-19 pandemic. These increases include updated state funding, additional federal funding through the CARES Act, and a reduction in charges for programs that are operating at a reduced capacity. The General Fund budget expenditures increase \$13,858,819 related to adjustments to staffing salary and benefit costs, technology, and the response to the COVID-19 pandemic. As a result, fund balance is projected to increase by \$100,885 to \$38,329,677.

The budget was reviewed in detail with the Board of Education at subcommittee meetings that occurred last week.

Based on this information, we recommend THAT the Rochester Board of Education adopt the following resolution for the General Fund.

RE: Recommendation for Purchase of 16 Buses through the MSBO 2020-2021 Bus Purchase

Program Bid

Currently the District owns and operates a fleet of 124 school buses. It is recommended that the District purchase a total of sixteen (16) school buses as detailed in the attached documents; of which ten (10) are 77-Passenger General Education buses, five (5) are 47-Passenger Special Education buses, and one (1) is a 65-Passenger Special Education bus to replace buses in the fleet that have reached their end of use. The amount for this purchase is \$1,492,253.00 as per the bid summary, and the cost of the MSBO Cooperative Bus Bid fee is \$1,250.00. This amount has been included as part of the Capital Projects - Bond 2015 budget. The MSBO bid vendors are:

- Midwest Transit Equipment
- Hoekstra Transportation Inc.
- Holland Bus Co.

The MSBO Competitively Bid Bus Purchase Program Bid documents are on file in the Purchasing Department. The Comparative Bid Price spreadsheet with the specification details and the Bid Summary sheet is attached.

In addition to Midwest Transit Equipment being the only bidder that met the specifications, the purchase of buses with the district standardized specs allows RCS to continue to standardize the parts inventory and maximize the mechanics' time. The Warranty offered by Midwest Transit Equipment is the best warranty and includes a five-year towing service and the capability to house an assortment of parts on-site at the District Bus Garage. Midwest Transit Equipment offers the best value since it is the only bidder able to provide the buses as specified and the most comprehensive Warranty Program. Also included on the buses from Midwest Transit Equipment are options that are not available on the other buses.

Based on this information, we recommend the District purchase in total sixteen (16) school buses (as detailed in the attached price comparison report) from Midwest Transit Equipment in the not to exceed amount of \$1,492,253.00, as per the MSBO Bus Purchase Program Bid, plus the MSBO Cooperative bus bid fee of \$1,250 for a total of \$1,493,503.00.

On October 15, 2020 the district advertised a Request for Proposal for Baseball and Softball Fields Safety Netting in the local publication, the Rochester Post, and posted RFP documents on the Purchasing pages of the district's website, Sigma, and BidNet Direct. The district received two (2) responsive bids on the due date and a public bid opening was conducted on October 29, 2020 at 2:30pm.

The scope of the project includes installation of safety netting at two (2) baseball fields and three (3) softball fields at the district high schools.

Proposals were evaluated by the Director of Capital Projects & Facilities, Pete Muscio. Compliance with bid requirements was reviewed by the Purchasing Supervisor, Jennifer Fickel. The original bid documents are on file in the Purchasing Department, and the proposal summary is attached. The source of funding is the 2015 Bond.

Based on this information, we recommend the District award the Baseball and Softball Safety Netting project to Michigan Fence Outlet, in the amount of \$36,000.00 and to approve a contingency amount of 5% for a total project not-to-exceed amount of \$37,800.00.
