Dear RCS Families,

Thank you for your continued support as students at all grade levels complete their first week of full-time, in-person learning for the 2020-21 school year. We are so pleased to have our children back in the school buildings, and we remain committed to evaluating our processes and protocols to keep our community as safe as possible.

To that end, we have been looking at different reporting options to help our families better understand the number of positive COVID-19 cases within our district, along with the number of students and staff who are quarantined. We will continue to notify individual school communities of building-specific cases. Students or staff members who may have had direct exposure will be personally notified and will receive a separate communication providing specific guidance.

We expect to report this data weekly. The following information is from March 4, 2021. Please note that this information is reflective of one point in time. Having cases present in school buildings does not indicate that the person's exposure occurred at school.
