#### 1. M-STEP

Executive Director of Elementary Education Michael Behrmann, along with Curriculum Consultants Susan Rapp, Ashley Painter and Lisa Ogiemwonyi and Early Literacy Coach Wendy Beitel shared the Elementary M-STEP results for the 2016-2017 school year. Comparisons were made to comparable surrounding districts, county, and state results.
