# MINUTES

## CALL TO ORDER AND PLEDGE OF ALLEGIANCE

A Special Meeting, Open to the Public, of the Board of Education for the Rochester Community Schools, Rochester, Michigan was held on Monday, December 17, 2012, in the Rochester Community Schools Administration Center, 501 West University Drive, Rochester, Michigan. President Jennifer Berwick called the meeting to order at 7:02 p.m. Board members led in the Pledge of Allegiance.

Dr. Zumsteg shared the activities that have taken place over the weekend to communicate with parents and establish additional security protocols. The principals met with their staff this morning, the District Critical Incidence team met to review protocols and the principals met with Dr. Zumsteg later in the day to review the day's events. The consensus from these meetings is that the district will continue to have the entrances locked after the students enter the building. The Oakland County Sheriff's Office will begin their Adopt-a-School, where patrol cars will stop by schools periodically. There is a bidding process in place at Oakland Schools for heightened security measures if districts want to pursue this. Dr. Zumsteg will be having further conversation with the Board about this.
