Call to Order

A Regular Meeting, Open to the Public, of the Board of Education for the Rochester Community Schools, Rochester, Michigan was held on Monday, January 13, 2014, at RCS Administration Center, 501 West University Drive, Rochester, Michigan 48307. Reports

A. Superintendent's Committee Reports (Information Item) Mr. Romzek

Mr. Romzek shared information from the Superintendent's Business and Operations Committee meeting that took place on January 7, 2014. Discussion included the monthly budget report and the 2013/2014 budget amendment.

B. 2013/2014 Budget Amendment (Action Item) Mr. Romzek

Mr. Romzek presented details of the 2013-14 Budget Amendment and answered Board questions. The amendment increases the deficit in the adopted budget by approximately \$600,000 due to a combination of revenue and expenditure variances from the adopted budget. This in turn reduces the projected fund balance from 10.5% to 10.1% of expenditures.

Board discussion and questions included fund balance, spending restrictions, capital improvement list, Best Practices funds, budget variance, increasing revenue, financial reporting system, student reporting software, school funding, donor district, and prioritize instruction.

Doug Hill, President of REA, addressed the Board regarding the school budget and finances.

Sarah Macbeth, teacher, addressed the Board regarding the school budget and finances.

A motion was made to approve the 2013/2014 Budget Amendment as presented.



A Little About The Law

- In October 2012, Michigan became the 39th state to enact a law that protects young athletes from the consequences of sports concussions
 - Actually, two laws Public Acts 342 and 343 of 2012
- The law went into effect June 30, 2013
 - Your District should already by complying with it!
- Goals
 - Promote greater awareness of concussions and their consequences
 - Create concussion awareness training program for coaches, adult employees, and volunteers of athletic activities
 - Protections for athletes showing signs of a concussion







Why Are We Talking About This Law?

 A non-public school, public school, or public school academy are considered an organized entity subject to the law's requirements

More About The Law



- Defines a concussion as "a type of traumatic brain injury as recognized by the Centers for Disease Control and Prevention. A concussion may cause a change in a persons mental status at the time of the injury, including, but not limited to, feeling dazed, disoriented or confused, and may or may not involve a loss of consciousness."
- A concussion may be caused by any type of accident or injury including, but not limited to:
 - A fall
 - A blow, bump, or jolt to the head or body
 - The shaking or spinning of the head or body
 - The acceleration or deceleration of the head







To What Activities Does The Law Apply?

- Any "athletic activity"
 - "a program or event, <u>including practice or competition</u>, during which youth athletes participate or practice in an <u>organized athletic game or competition against another team</u>, <u>club</u>, <u>entity</u>, <u>or individual</u>. Athletic activity <u>includes</u> participation in <u>physical education classes that are part of a school curriculum."</u>
 - · Field Days
 - Practices
 - Out-of-season camps/clinics

How Does The Law Work?



- All coaches, employees, volunteers, and other adults involved with an athletic activity must complete a concussion awareness online training program
- A district must provide educational materials on the signs/symptoms and consequences of concussions to each youth athlete and their parents/guardians
 - A district must obtain a signed statement acknowledging receipt of the information by the parent/guardian and athlete
 - A district must retain the athletic statement for the duration of the youth athlete's participation in the athletic activity or until he/she is 18 years of age







- The law requires immediate removal of an athlete from physical participation in an athletic activity who is suspected of sustaining a concussion
- A youth athlete cannot return to physical activity until an evaluation has been conducted by an "appropriate health professional" who provides written clearance authorizing the youth's return to physical participation in the athletic activity
 - "A health professional who is licensed or otherwise to engage in a health professional and whose scope of practice includes the recognition, treatment or management of concussions"
