## **MINUTES**

### Call to Order

A Regular Meeting, Open to the Public, of the Board of Education for the Rochester Community Schools, Rochester, Michigan was held on Monday, April 14, 2014, at RCS Administration Center, 501 West University Drive, Rochester, Michigan 48307. President Lisa Nowak called the meeting to order at 7:00 p.m. Board members led in the Pledge of Allegiance.

Ms. Nowak read the following statement: The Rochester Community Schools Board of Education continues to receive inquiries and comments regarding the status of negotiations with the Rochester Education Association

The REA contract expired August 15, 2013. Since that time REA members have been working under all provisions of the expired contract including salary and benefits within the parameters of Public Act 54. Public Act 54 prohibits the district from providing any increases to salary including steps or educational lane changes to those who would be eligible, and any increase in benefit costs once a contract expired.

The Board of Education values the dedication and hard work of our teachers. We understand that the REA has a responsibility to represent the best interests of its members. We also understand that the Board has a responsibility to be good stewards of the district's resources and manage them with a commitment to sustainability. We are confident that both parties are working diligently to come to a mutual labor agreement that honors both parties' responsibilities and preserves educational opportunity for all students.
