Request for Bids

Rochester Community Schools invites you to provide a bid for <u>Marquee Sign</u> per the specifications set forth herein.

Bid Information and Requirements for Acceptance:

All bids, required forms, and pricing shall be submitted electronically on BidNet Direct (https://www.bidnetdirect.com) no later than 2:00 p.m., local time, July 15, 2021 (the "Due Date".) No oral, telephonic, or facsimile proposals will be considered.

RCS will not consider or accept any late Bids received after the Due Date specified within the RFB. It is the sole responsibility of the Bidder to ensure their bid is entered completely and forms are uploaded on BidNet Direct before the closing date and hour indicated within the RFB. Bidders shall plan ample time to respond to all requirements and input all requirements. RCS is not responsible for any delivery delays.

Included in your response shall be one (1) of each of the following forms:

- Vendor Information Form, signed
- Vendor Price Quotation on Vendor Bid Form inclusive of specifications on "Attachment A" with pricing breakdown specified in "Project Scope and Background"
- Iran Economic Sanctions Certification Form, signed
- Familial Disclosure Statement Form, signed and notarized
- 5% Bid Bond

Bid Opening and Public Reading:

All bids will be opened and read aloud immediately following the Bid Due Date at 501 West University Drive, Rochester, MI 48307. Compliance with all local health orders and guidelines for public gatherings in effect on the Bid Opening date will be enforced.

Bidder's Instructions:

- 1. The price quoted on the Vendor Price Quotation must be net. Discounts, rebates, and allowances will be used as criteria of evaluation, but must be stated separately on the Vendor Price Quotation.
- 2. The buyer has the right to cancel a purchase order if the terms and conditions set forth herein are not met.
- 3. Prices bid are to include shipment delivered to the district location as specified.
- 4. All purchases are to be exempt from all taxes including State and Federal taxes. An exemption certificate will be furnished upon request.
- 5. Bids must meet or exceed all specifications herein. Any deviations from the specifications set forth must be clearly detailed on the bid proposal form; otherwise, it will be considered that

- items offered are in strict compliance with the specifications, and successful bidder will be held responsible therefor.
- 6. The Board of Education reserves the right to accept any item in the bid; to accept or reject any or all bids; to waive any informality herein; or for reasons of establishing uniformity, to award the contract to other than the low bidder.
- 7. This bid is made without any previous understanding or agreement with any other person, firm or corporation making a bid for the same purpose, and is in all respects fair and without collusion or fraud.
- 8. No member of Rochester Community Schools Board of Education, City, State or any officer, employee or person whose salary is payable in whole or in part from the treasury of said Board of Education is directly or indirectly interested in this bid or in the supplies, materials, equipment, work, services or any portion of the profits thereof to which it relates.
- 9. All Bids shall be accompanied by a sworn and notarized statement disclosing any familial relationship that exists between the owner(s) or any employee of the Bidder and any member of the Board of Education of the School District or the Superintendent of the School District. In addition the Bid must include the signed Iran Economic Sanctions Certification. Bids that do not include the sworn and notarized Familial Relationship disclosure statement and the signed Iran Economic Sanctions Certification will not be consider by the Board of Education.
- 10. Any manufacturers' names, brand names, trade names, or catalog numbers used in the specification are there for the purpose of establishing and describing general performances and quality levels. Such references are not intended to be restrictive, and bids are invited on these and comparable brands or products of any manufacturer.
- 11. Vendor shall not during the contract assign, transfer or subcontract any part of agreement to any other supplier.
- 12. The vendor shall agree to a "Hold Harmless" clause concerning the process, selection criteria, award, and contract as entered into with RCS.

13. SOLE BIDDER

- a. It is the District's intent that this Request for Bids permit competition. It shall be the bidder's responsibility to advise Rochester Community Schools, in writing, if any language, requirements, scope specifications, etc., or any combinations thereof, inadvertently restricts or limits the requirements stated in this Invitation to Bid to a single source. Rochester Community Schools shall receive such notification no later than five (5) days prior to the date set for acceptance of bids.
- b. If only one bid is received in response to the RFB, a detailed cost proposal will be requested of the single seller. A cost/price analysis and evaluation and/or audit shall be performed of the cost proposal in order to determine if the price is fair and reasonable.
- c. Rochester Community Schools reserves the right to cancel the bid, or reschedule the bid opening, if there is only one bid received. The decision by Rochester Community Schools will be final.

Project Scope & Background:

Rochester Community Schools (RCS) is seeking bids to provide and install an exterior digital marquee sign to replace the existing entrance sign in the entrance island at 52585 Dequindre Road.

The scope of the project entails a <u>complete installation</u> that includes, but is not limited to the following:

- 1. Remove existing masonry sign.
- 2. The new marquee sign to be installed is to match similar signs installed at the District's Middle schools (West, Hart, Reuther or Van Hoosen).
- 3. Provide a breakdown of costs showing:
 - a. Materials
 - b. Installation
 - c. Total Cost
- 4. Provide and install a new marquee per RFP requirements. See proposed basis of design drawing in Attachment 'A'.
- 5. Provide all shop drawings and design drawings for review and approval.
- 6. Demolition and removal of the existing sign.
- 7. Cleanup and repair of all areas affected by the installation.
- 8. Provide all required footings or foundations for a complete installation.
- 9. Provide all final electrical and network connections to the new sign (power feed and wired or wireless network connection to the antenna is to be provided by others).
- 10. Bidders are responsible for visiting each site to assess existing conditions to include in bid response and no additional costs will be allowed for failure to verify existing site conditions.

Specifications:

Marquee Sign:

The following specification contains the details the design requirements for the sign. No other substitutions will be acceptable.

The main sign is to be 83-3/8" (tall) x 126" (wide) x 24" (deep) ~73 Square Foot, two-sided custom fabricated aluminum sign with digital EMC on each face. Sign header and skirting\footer is to be internally illuminated with white JT "Street Fighter" LED lighting. Sign to include a two-sided electronic message center (EMC) by ThinkSign. Header and EMC is mounted via internal support steel posts and includes 18" (tall) x 126" (wide) x 24" (deep)" fabricated aluminum skirting\footer. Each side of the skirting\footer will have aluminum faces with routed copy of the street address backed with Lexan. Sign is direct burial in greenbelt and new concrete footings will be required.

Header Details:

22-1/2" (tall) x 126" (wide) x 24" (deep) ~20 Square Foot custom aluminum fabricated header cabinet that has aluminum faces to be a minimum of .125 gauge aluminum with routed copy and is backed with Lexan. The District logo is a routed circle from the aluminum face with surface applied vinyl to Lexan. Header to display the name of the building and the current Rochester Community Schools logo. The header is internally illuminated with white JT "Street Fighter" LED lighting. Two-sided.


CERTIFICATION OF COMPLIANCE – IRAN ECONOMIC SANCTIONS ACT Michigan Public Act No. 517 of 2012
