Work Session

A. Technology and Infrastructure 2020 Committee - Dr. Robert Shaner

Dr. Shaner introduced Technology and Infrastructure 2020 Committee Co-Chairs Cindy Lindner and Todd Bidlack.

Cindy and Todd facilitated a prioritizing exercise, giving the Board of Education an opportunity to provide the Tl2020 committee with additional direction on some key technology and facility items. During this process, questions from the consultants and Board members were gathered for future clarification.

Paul Theriault from Plante Moran CRESA reviewed the technology process and plan with the Board members. Board discussion included clarification of critical needs and cost contingency percentage, and which buildings are included in the Building Renovation category.

Paul Stauder from Stauder, Barch & Associates and Beverly Bonning from Thrun Law Firm reviewed capital financing options. Board discussion included clarification of bond vs. sinking funds, qualified bonds vs. non-qualified bonds, and the timeline of a ballot proposal.
